### California Children Services (CCS): Whole Child Model Transition

The Department of Health Care Services (DHCS) will begin transitioning CCS to the Whole Child Model (WCM) in July. This shift will integrate specialty care with Medi-Cal managed care for most children currently receiving CCS services. Notices about the transition will be mailed to affected families. Local health plans are seeking applicants for CCS Family Advisory Committees. Check your child's health plan Website for information.

### Funding: Self Determination Application Approved

The application for federal funding of the **Self-Determination Program** has been approved by the Centers for Medicare and Medicaid Services (CMS). This is an essential step toward providing people who receive regional center services and their families an alternative way to coordinate their services, with more freedom and control over how the services are provided and the individuals who support them. Providing information and support, in particular training and orientation materials, needed to assist those who are selected and choose to participate is central to implementation and is in the final stages of completion.
